## WHAT TO DO *Some options to consider...*

### GET TO A SAFE PLACE

### TALK TO SOMEONE

Violence Prevention & Response (VPR) is available for confidential support, information, and resources.

### PRESERVE EVIDENCE

For Sexual Assault:

- Physical evidence may be necessary to prosecute the offender and may be helpful in obtaining an Order of Protection.
- If at all possible, do not bathe, wash your hands, use the toilet, drink, smoke, change clothing, or brush your teeth.
- Cambridge Hospital and MGH are nearby “SANE” sites, which have specially trained sexual assault nurse examiners who care for victims of sexual assault and conduct a “medical evidence collection kit” at no direct cost to you.
- You don’t need to file a police report to get a forensic exam. VPR can accompany you to this exam.

Keep emails, text messages, social media postings, or any other information about the incident.

### SEEK COUNSELING

Confidential counseling is available to students through MIT Mental Health & Counseling Services and to employees through MyLife Services

### SEEK MEDICAL ATTENTION

Cambridge and MGH can provide medical services and conduct evidence collection. Medical services are also provided on campus to students by MIT Medical.

### REPORT THE INCIDENT

Parties are encouraged to report to the Institute Discrimination & Harassment Response (IDHR) Office and/or MIT Police. This is not a requirement.

*Note:* Retaliation against anyone who files a report is strictly prohibited. Reports of retaliatory behavior will be investigated and could lead to disciplinary action.

## WHAT YOU CAN EXPECT

- To be informed of all reporting options and not pressured to make a report
- To be notified of existing campus and community resources whether or not the crime is reported to campus or civil authorities
- To be informed of options for, and assistance with, making changes to academic, living, transportation, and working situations as well as protective measures offered by MIT.

## OPTIONS TO DETER CONTACT

- **INSTITUTE-BASED NO-CONTACT ORDERS FOR STUDENTS:** The IDHR Office can assist in establishing a mutual no-contact order between parties at MIT, whether or not there is a formal complaint filed. A violation of the no-contact order can result in disciplinary action through the MIT Committee on Discipline. Email [idhr@mit.edu](mailto:idhr@mit.edu) for more information.
- **PROTECTIVE ORDER:** A court-issued order that can be enforced anywhere in the United States, no matter where you obtain this order. A violation of this order can result in criminal charges. MIT Police, IDHR, and VPR can provide information and support throughout this process. Once issued, MIT will also work with you to make any accommodations necessary.

However, in planning any response, the wishes of the reporting individual are given full consideration.

# REPORTING OPTIONS

You may pursue any or none of these options. You are not required to file a report immediately; but it is important to preserve any evidence of the incident. Visit [idhr.mit.edu](http://idhr.mit.edu) for detailed information about reporting options. MIT will take steps to keep your information private to the extent allowed by law.

## REPORTING TO THE POLICE FOR A CRIMINAL COMPLAINT

You are not required to file a criminal complaint. If you choose to, MIT will provide you with support throughout the process. You may file a criminal complaint by contacting the police. A criminal complaint is governed by applicable criminal statutes; the standard of proof is “beyond a reasonable doubt;” and potential sanctions include all applicable criminal sanctions, up to and including incarceration. ## INCIDENT REPORTING TO IDHR AT MIT

If the alleged perpetrator is affiliated with MIT, you may file a complaint with the Institute by contacting the IDHR Office. You have the right to file a complaint with MIT even if police conclude they do not have sufficient evidence for a criminal charge. The complaint is governed by the Institute’s Policies. You may seek either “formal” or “informal” resolution; the standard of proof is “a preponderance of the evidence;” and sanctions may include suspension or expulsion (for students) and termination (for employees). You can also report to MIT anonymously using our incident reporting form on [idhr.mit.edu](http://idhr.mit.edu).

## INSTITUTE FORMAL COMPLAINT & INVESTIGATION PROCESS

MIT strives to provide a prompt, fair, and impartial process from the initial investigation to the final result. Investigations are conducted by trained IDHR staff.

During an investigation both the Complainant (reporting party) and the Respondent (responding party) will:

- Have the opportunity to be accompanied by an advisor of their choosing to any investigation related meeting or proceeding.
- Receive notification in writing of the result of any complaint investigation, procedures for appeal (when available), any changes to the result, and when the results become final.
